Recognized Courses in

Accounting/Business Communications

July 26, 2024

Board Rule 511.58(d) – Definitions of Related Business Subjects to take the UCPAE requires the completion of a minimum of two (2) upper level semester credit hours in accounting communications or business communications with an intensive independent writing curriculum. This course(s) is required to take the CPA Exam. The course may also be used to meet the 24 semester credit hours of upper level business courses required to take the CPA Exam. For additional information on the requirement, refer to <u>Texas Administrative Code (state.tx.us</u>). The following courses listed are recognized by the Board as meeting this requirement.

A minimum of two (2) semester hours in accounting communications OR business communications must be completed at a Board-recognized college or university. The course must be upper level and an independent intensive writing course A syllabus should be provided to document the amount and level of independent intensive writing found in the course. The hours may be obtained through a stand-alone course or offered through an integrated approach. If the independent intensive writing is offered through integration, the educational institution must provide syllabi of the courses to document the content. Where the integration approach is used, one (1) semester hour, or quarter hour equivalent must be dedicated to independent intensive writing in each approved course. To assist in identifying courses that may meet this requirement, the following information is provided. Courses with the same or similar names but offered at a different institution will not be recognized as meeting this requirement.

Course(s) identified by a university to meet the requirements for accounting or business communications should include basic writing mechanics; effective business writing principles, including organization, clarity, and conciseness; ability to exchange technical information and ideas with co-workers and other professionals; prepare documents and presentations that are concise, accurate, and supportive of the subject matter; document and cross-reference work performed and conclusions reached in an accurate manner; assist clients in recognizing and understanding implications of critical business issues by providing recommendations and informed opinions; and prepare and present written work products in the form of memos, letters, opinions, and reports – such as audit reports – to others.
